SmartWitness has been providing in-vehicle cameras to fleet operators since 2007 and was a pioneer in creating the first commercial grade dash camera. Today, SmartWitness is responsible for the protection of over 250,000 vehicles around the world covering in excess of 35 million miles every day.

"Our annual fleet telematics survey and other recent research suggest video solutions will continue to see increasing demand," said Howard Smith, Managing Director at First Analysis. "After studying the market, we believe SmartWitness is the leading video solutions provider with an uncommon business model designed to support the existing fleet telematics provider channel, enabling vendors to compete with point solutions providers in video.
